## MOVING FORWARD TOGETHER

Hundreds of neighborhoods and thousands of families have been devastated by the economic crash and housing crisis. Fortunately, there is hope. With the support of many partners, Mercy Housing has built or preserved over 1,100 affordable homes and sustained 3,000 jobs during the last two years.

With your help, we can do more. Your support will help us sustain and ultimately fulfill our ten-year Moving Forward Together campaign to build or preserve 7,500 affordable homes, create 8,000 jobs, and prevent homelessness for 20,000 people.

This work includes the efforts of two sister organizations. The first is Mercy Housing Lakefront which has developed and currently manages 23 large rental properties enabling 3,300 people to live in hope. The second is Mercy Portfolio Services which manages Chicago's Neighborhood Stabilization Program with a goal to rehab and reoccupy thousands of foreclosures.


Our goal is to help people like Bridgette. Following a lay-off, she and her family were one week away from foreclosure, eviction, and potential homelessness. Fortunately, they were able to move into a new affordable home at Mercy's Wentworth Commons Apartments. Once settled, our staff provided training and resources to help her find a new job. Today, she has turned her life around. She is now employed at Treatment Alternatives for Safe Communities and gives back by helping others find jobs and housing. She tells her clients, "Don't give up, keep going. Even through the recession, whatever may come your way, you can get through it."
