

Chicago to Host 2013 ULI Fall Meeting



ULI Chicago is making preparations to host the 2013 ULI Fall Meeting November 5-8 in Chicago. Sam Zell, *Founder* and *Chairman* of Equity Group Investments, has agreed to participate as 1 of 6 notable keynote speakers at the event. The ULI Fall Meeting attracts over 7,000 attendees and draws real estate leaders from all facets of the industry to collaborate on current real estate issues, network with peers and learn the latest trends in real estate. Registration is set to open in May and the convention will be located at Chicago's expansive McCormick Place.

Teri Frankiewicz, *Vice President* at Crown Community Development, and Randy Rowe, *Chairman* of Green Courte Partners, LLC, are the co-chairs of the Local Arrangements Committee. Ms. Frankiewicz is enthusiastic about hosting the Fall Meeting in Chicago, "We are thrilled that Chicago will be the host city for the ULI Fall Meeting this year. 
Urban Inspiration Contest

This quarter's topic is the old Prentice Women's Hospital. Prentice Women's Hospital, designed by Chicago architect Bertrand Goldberg and completed in 1975, was groundbreaking for its cutting-edge cantilevered concrete design, advanced engineering and its progressive plan for the organization of medical departments and services. Now, merely 38 years old and without landmark protection, this amazing masterwork is threatened with demolition by Northwestern University. University officials have made it known that they plan to demolish the building for the construction of a new research/laboratory facility. The University says it needs new biomedical research facilities and that Prentice is too small, old and quirky to feasibly retrofit. All entries should be posted by April 30, 2013.
